

Eligibility of Candidates:

No candidate can contest election for any post of office bearers for more than one term.
No candidate can contest election for more than two posts of the office bearers.

(a) President/President (Elect) :

No person may seek election to the office of the President/ President (Elect) unless he satisfies either of the criteria as described hereunder.

- (i) The candidates must have been a Life member of the Association continuously for not less than 120 months, including 60 months as member of the local Working Committee or State Working Committee or Central Working Committee. Furthermore, he should have held the office of the Hony. Secretary or Treasurer or Vice President of the association for one full year.
- (ii) A candidate belonging to the Govt. Services, either State, Central or Armed Forces, may seek election to the office of President provided he has at least two years continuous membership of the local branch at the time of the contesting the election, including two years as elected member of local Working Committee. This two years period should be completed on September 30. Furthermore, he should have a continuous membership of I.M.A. for at least 180 months and more he should have held the office of the Hony. Secretary or Treasurer or Vice President of the local branch of the Association for one full year.

(b) Vice-President/Hony. Secretary/Treasurer

No person may seek election to the post of Vice President, Hony. Secretary or Treasurer unless he satisfies either of the criteria as described hereunder:-

- (i) The candidate must have been a Life member of the Association for not less than 84 months, including 36 months as member of the Working Committee or State Working Committee or Central Working Committee.
- (ii) A candidate belonging to Govt. services either State Central of Armed Forces may seek election to these offices provided he has at least one year of continuous membership of the local branch, including one year as elected member of local Working Committee at the time of contesting the election. This one year period should be completed on September 30. Further, more-more, he should have a continuous membership of I.M.A. for a minimum period of 120 months.

(c) Member of the Working Committee / Joint Secretary (elected):

A candidate seeking election for all other posts in the Executing Committee must have been a Life member of the Association for a minimum period of 24 months.

(d) Cultural Secretary/Scientific Secretary/ Editor

No person may seek election to the post of Cultural Secretary/Scientific Secretary/ Editor unless he satisfies either of the criteria as described hereunder:-

The candidate must have been a Life member of the Association for not less than 60 months, including 24 months as member of the Working

- (i) Committee or State Working Committee or Central Working Committee.
- (ii) A candidate belonging to Govt. services either State Central of Armed Forces may seek election to these offices provided he has at least one year of continuous membership of the local branch, including one year as elected member of local Working Committee at the time of contesting the election. This one year period should be completed on September 30. Further, more-more, he should have a continuous membership of I.M.A. for a minimum period of 84 months.
- (iii) For Scientific Secretary & Editor candidate should have post graduate qualification.

Section 5: Chairman, Secretary / Treasurer of IMA AMS/ Faculty Asstt. Director/ Sub Faculty Secretary / Treasurer, Members of IMA CGP

No person may seek election to the post of IMA AMS/ IMA CGP unless he satisfies either of the criteria as described hereunder:-

- (i) The candidate must have been a Life member of the Association for not less than 60 months, including 24 months as member of the Working Committee or State Working Committee or Central Working Committee.
A candidate belonging to Govt. services either State Central of Armed Forces may seek election to these offices provided he has at least
- (ii) One year of continuous membership of the local branch, including one year as elected member of local Working Committee at the time of contesting the election. This one year period should be completed on September 30. Further, more-over, he should have a continuous membership of I.M.A. for a minimum period of 84 months.
- (iii) For any post of IMA AMS/IMA CGP member should be Life member of IMA AMS/ IMA CGP respectively.

For the other Post:-

1. Candidate should be member of IMA continuously for last 3 years
2. Member seeking re-election for the post of representative of IMA Agra to central or state council for the following year should have attended at least one central/state council meeting of current year except when exempted by the chair upon written request.

Candidate has to deposit nomination fee (non refundable) as under:
